WEEDS & MOWING

It is that time of year again when the grass and weeds take over our lawns. It is the responsibility of all property owners to keep their land and the adjacent parking areas free of weeds and grass that are 9" or taller. The City will have any uncontrolled weed growth abated without prior notice to the property owner. The cost of the abatement will be billed to the property owner along with a \$75 administrative fee. Do not mow, or sweep grass clipping onto the street or curb!



COMPREHENSIVE PLAN UPDATE 2022

What is the Carter Lake Comprehensive Plan Update?

Carter Lake is taking part in an effort to ensure that our development regulations support our efforts to expand economic development and housing opportunities.

This handout is intended to inform Carter Lake residents, property and business owners, and other stakeholders about the planning update. This handout provides information about why the City is undertaking this initiative, what it means to you as a resident, where you can find more information, and how to engage in the discussion and outcomes.

What is a comprehensive plan?

A comprehensive plan is a policy document for governments to provide the basis for future decisions on regulations, funding, and the built environment.

A comprehensive plan expresses a community's values and preferences. It is the foundation for development decisions, laws, regulations, and policies. It reflects a community's desired future.

While every comprehensive plan is unique, in general, all address four topics: (1) existing conditions, (2) goals and objectives, (3) implementation strategies and (4) the future land-use map.

Why is the City rethinking Carter Lake's plan?

The current version of the City's Comprehensive Plan was adopted in 2006. The world and Carter Lake have changed significantly since that time. Updating the Comprehensive Plan and the future land use map will also support desired zoning changes to facilitate the growth and development of Carter Lake in the upcoming years.

What is the timeline for Planning Updates?

Announce results of public input from survey, and ask for feedback on draft of comprehensive plan

August 15-31:

Two-week comment period for draft plan

September 1-16:

Incorporate additional public feedback into the draft comprehensive plan

**September 19, 7 pm,
Carter Lake City Hall**

Present final Comprehensive Plan at City Council Meeting

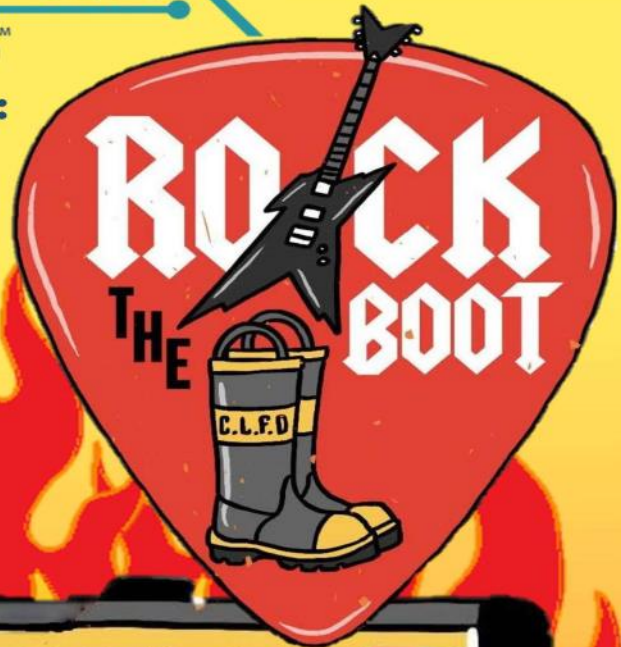

SWIMMING POOL REGULATIONS

Permit fee: \$30

No person shall construct, enlarge, alter, or otherwise improve a swimming pool that contains water over 24 inches deep, whether temporary or permanent, without first obtaining a permit. Permanent swimming pools shall obtain a one-time permit, unless alterations or modifications occur which shall require the submission for a new permit.

All pools with a depth of eighteen (18) inches or greater, shall be completely surrounded by a barrier, fence or solid structure (house or garage wall) and shall have no opening, other than doors or gates, except as listed in 1 & 2 below.

Minimum of six (6) foot high barrier, fence or solid structure is required for all pools (In-ground, partially in the ground, or above-ground and all others, capable of holding water **greater than forty-two (42) inches**).

Minimum forty-two (42) inches high barrier, fence or solid structure is required for all other pools capable of holding water from **eighteen (18) to forty-two (42) inches in depth**.

Such barrier fence, solid structure or wall shall be constructed of sufficiently strong materials and of such structural design as to make the pool inaccessible to small children:

1. The barrier, fence or other solid structure shall have no openings of more than four (4) inches.
2. All gates or doors shall: Be equipped with a self-closing, self-latching and lockable door or gate securely closed at all times when not in actual use. Have all latches or locking devices on doors and gates not less than forty-two inches above the adjoining walls, steps, or ground.

At all times, when the pool is “unattended”, such gates, doors, steps, ladders, ramp or other vehicles affording access to the pool shall be secured against unauthorized access. “Unattended” means the absence of an adult person in the outdoor swimming pool or within constant eyesight of said pool and no more than twenty (20) feet therefrom.

3. Barriers may include not only fences, walls, or solid streamline, but may also include decks, the pool structure itself and above-ground fencing that is specifically attached to pools as designed by the manufacturers of pools. However, barriers shall not include items that are unsightly, subject to usually fast wear and tear or otherwise made of materials not designed for use around outdoor swimming pools.

Location and Distance from Property Line.

No part of a swimming pool, or its related structure shall be constructed with seven (7) feet of a property line, other wall, fence or other structure which can be readily climbed by children.

Pools shall be located only in rear or side yards and shall not be located in front yards.

Inspection.

Persons maintaining a swimming pool pursuant to this chapter shall be deemed to consent to periodic inspections of same for compliance with this and other chapters in this Code of Ordinances at reasonable times by City employees.

Enforcement.

This requirement shall be applicable to **all new swimming pools** hereafter constructed, other than indoor pools, **and shall apply to all existing pools which have a minimum depth of eighteen (18) inches of water**. No person in possession of land within the City, either as owner, purchaser, lessee, tenant or licensee, on which is situated a swimming pool having a having a minimum depth of eighteen (18) inches, shall fail to provide and maintain such barrier fence or wall as provided in this section.
